

SPRING OF LIFE TESLA GIVEAWAY

OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT WILL NOT IMPROVE THE CHANCES OF WINNING. VOID OUTSIDE THE STATE OF CALIFORNIA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

1. SPONSOR

The "Spring of Life Tesla Giveaway" (the "Sweepstakes") is sponsored and administered by **Spring of Life Church**, a registered 501(c)(3) nonprofit organization located at **5948 Pecan Ave, Orangevale, California 95662** (hereinafter referred to as "Sponsor"). Sponsor shall have the sole and exclusive responsibility for the operation and administration of the Sweepstakes and reserves the right to amend or modify these Official Rules at any time, with or without notice, subject to applicable law.

2. ELIGIBILITY

The Sweepstakes is open only to natural persons who are legal residents of the State of California and who are eighteen (18) years of age or older at the time of entry (each, an "Entrant"). All Entrants must possess valid government-issued identification and be legally capable of entering into binding contracts under applicable law. The Sweepstakes is void outside California and where prohibited or restricted by law. Employees, officers, directors, representatives, agents, and immediate family members (defined for purposes of this Sweepstakes as spouses, parents, siblings, children, and household members, whether related or not) of Sponsor, and any person or entity involved in the administration, development, execution, or fulfillment of the Sweepstakes are not eligible to enter or win. Sponsor reserves the right, in its sole discretion, to determine eligibility, and any such determination shall be final and binding in all respects.

3. SWEEPSTAKES PERIOD

The Sweepstakes begins on April 6, 2025, and ends on May 3, 2025 (the "Sweepstakes Period"). Entries received before or after the Sweepstakes Period will not be valid and will be disqualified without notice.

4. METHODS OF ENTRY

There are two (2) methods of entry for the Sweepstakes, as described below. All entries become the property of the Sponsor and will not be acknowledged or returned.

(A) Paid Entry:

Entrants may receive one (1) entry into the Sweepstakes for each qualifying donation of fifty U.S. dollars (\$50.00) made to Sponsor. Donations may be made either: (i) in person at Sponsor-approved events or locations; or (ii) online via Stripe through the designated payment link located at <https://sol-tesla.com>. There is no limit to the number of total entries that an Entrant may submit, provided that each transaction is limited to no more than fifty (50) entries. Only transactions that are successfully processed by Sponsor during the Sweepstakes Period will be deemed valid and eligible for entry.

(B) Free Mail-In Entry:

Entrants may alternatively enter the Sweepstakes without making a purchase by submitting a hand-written mail-in entry as follows: Entrant must legibly handwrite, using **red ink**, on a 3" x 5" unlined, cream-colored index card the following: full legal name, California residential address (no P.O. boxes), telephone number, email address, and date of birth, along with the following statement: *"I wish to enter the Spring of Life Tesla Giveaway without making a purchase."* This card must be enclosed in a standard #10 envelope (measuring approximately 4.125" x 9.5"), bearing sufficient postage, and mailed to:

To be eligible, mail-in entries must be postmarked on or before April 27, 2025, and received by Sponsor no later than May 1, 2025. Only one (1) mail-in entry per person will be accepted. Any bulk entries, mechanically reproduced, illegible, incomplete, late, mutilated, misdirected, or otherwise non-compliant entries shall be deemed void and will not be acknowledged or entered into the Sweepstakes. Sponsor is not responsible for lost, late, or misdelivered entries, or for entries that do not comply with these Official Rules.

5. PRIZE

One (1) Grand Prize will be awarded to one (1) eligible winner drawn at random during the event described in Section 6. The Grand Prize consists of: one (1) 2024 Tesla Model 3 Dual Motor with gray exterior paint, black interior, and **salvage title** (the "Prize"). The estimated fair market value ("FMV") of the Prize is thirty-three thousand U.S. dollars (\$33,000.00 USD). The vehicle is awarded "AS IS" and "WITH ALL FAULTS" and without any warranty or guarantee, express or implied, by Sponsor. The vehicle may have sustained previous damage and may not meet registration or emissions standards in all jurisdictions. The Prize is not transferable or assignable and may not be exchanged for cash or any other consideration.

The Winner shall be solely responsible for all federal, state, and local taxes, fees, insurance, registration, and any other expenses related to the acceptance, receipt, ownership, operation, or use of the Prize. Sponsor makes no representations or warranties regarding the vehicle's condition, safety, or title status.

6. WINNER SELECTION AND REQUIREMENTS

The potential winner (the "Winner") will be selected via a random drawing to occur live at the **Mriya Fest** event on **May 3, 2025** in Sacramento, California. **Winner must be physically present in person at the time of the drawing in order to be eligible to receive the Prize.** If the selected winner is not present when their name is announced, such individual shall be deemed to have forfeited the Prize, and an alternate winner may be selected at Sponsor's sole discretion. Sponsor's decision as to the Winner shall be final and binding in all respects.

7. TAXES AND IRS REPORTING

As required by applicable law, the Winner will be required to complete an Internal Revenue Service Form W-9 prior to receiving the Prize. The fair market value of the Prize will be reported on IRS Form 1099-MISC issued in the name of the Winner. All income and other taxes, as well as any costs associated with claiming or using the Prize, are the sole responsibility of the Winner. Sponsor strongly encourages the Winner to consult with a qualified tax advisor regarding potential tax consequences of accepting the Prize.

8. RELEASE OF LIABILITY

By participating in the Sweepstakes, each Entrant agrees to release, indemnify, and hold harmless Sponsor, its officers, directors, employees, volunteers, representatives, agents,

affiliates, and successors (collectively, the "Released Parties") from any and all claims, causes of action, damages, losses, liabilities, costs, or expenses (including attorneys' fees) arising from or related to participation in the Sweepstakes or the receipt, ownership, use, or misuse of any prize awarded. The Released Parties are not responsible for any error, omission, interruption, deletion, defect, delay, theft, or destruction of entries, nor for unauthorized access or alterations to entries or technical failures of any kind.

9. PUBLICITY

By accepting the Prize, the Winner grants to Sponsor the perpetual, worldwide, royalty-free, and unrestricted right and license to use the Winner's name, image, likeness, voice, and city of residence in promotional materials, advertising, and announcements in any media format now known or hereafter developed, without further compensation or approval.

10. GENERAL CONDITIONS

Sponsor reserves the right to cancel, suspend, or modify the Sweepstakes at any time, without notice, in its sole discretion, if fraud, technical issues, or other causes corrupt the administration, integrity, or security of the Sweepstakes. Any attempt by an individual to deliberately damage or undermine the legitimate operation of the Sweepstakes is a violation of criminal and civil law, and Sponsor reserves the right to seek damages and other remedies to the fullest extent permitted by law.

11. DISPUTE RESOLUTION

All disputes arising from or relating to this Sweepstakes shall be governed by and construed in accordance with the laws of the State of California, without regard to conflict of laws principles. Any legal action must be brought exclusively in the state or federal courts located in **Sacramento County, California**, and each Entrant hereby submits to the jurisdiction of such courts. EACH ENTRANT WAIVES THE RIGHT TO PARTICIPATE IN ANY CLASS ACTION LAWSUIT OR JURY TRIAL ARISING FROM OR RELATED TO THIS SWEEPSTAKES.
