OPEN FIELD CAPITAL LLC PRIVACY POLICY

Effective: 6th December, 2023

In order to comply with the disclosure requirements of Regulation S-P, the Chief Compliance Officer shall cause the following Privacy Policy to be distributed to all new clients and to all existing clients no less often than annually. This Privacy Policy is also posted on our website in order to notify website users of our consumer personal data privacy practices.

Open Field Capital LLC ("OFC," "we" or "us") has a policy of protecting the confidentiality and security of information we collect and maintain on behalf of our clients and former clients. We consider preserving privacy to be fundamental to our relationship with our clients. In the course of providing investment management services, we necessarily collect and maintain information that identifies, describes or relates to you or can be reasonably associated with or linked to you ("personal information"). We will not share personal information with non-affiliated third parties without your consent, except as described below.

What Personal Information Do We Collect? We receive personal information about you, your organization and your portfolio from your investment management agreements, subscription agreements or other account application forms. We collect and maintain personal information about your transactions and your portfolio. We also gain access to personal information from our interaction with you on the telephone, in person or via e-mail. The categories of personal information that we collect includes; identifiers, such as first and last name, address, e-mail address; telephone number, social security number and internet protocol address; and commercial information, such as assets, liabilities, investment preferences and investment activity.

<u>What Personal Information Do We Disclose?</u> We limit the collection and use of personal information to the minimum that is required by us in order to deliver superior service. We do not disclose any personal information about our current or former clients, except in the following instances:

- as necessary to process a transaction;
- to service providers, including investment management software as a service providers; to contractors, including accountants and proxy services; or
- to regulatory agencies and as required by law.

The organizations that we provide your personal information to act on our behalf and use the personal information only to provide the services that we have asked them to perform for you and us. As emphasized above, we do not provide personal information to outside companies except in furtherance of our business relationship with you, or as otherwise permitted by law.

How Do We Protect Your Personal Information? We restrict access to your personal information to only those personnel who need access to such information in order to provide services to you and perform their designated functions. Our personnel are required to protect the confidentiality of personal information and to comply with our established policies. Personnel

who violate our Privacy Policy will be subject to disciplinary action. We also maintain physical, electronic, and procedural safeguards that comply with industry standards to guard your personal information.

<u>May Other Parties Collect Personal Information from Our Website?</u> We do not share your personal information with third parties for cross-context behavioral advertising purposes.

Do We Collect Personal Information from Children? We do not direct our website toward or knowingly collect any personal information from children under the age of 13. If you are under the age of 13, you may not use our website unless you provide us with your parent or guardian's name and contact information and they consent to your use of our website. If you are a parent or guardian and think that your child provided personal information on our website, please contact us immediately and, if you request, we will remove such information from our records.

Rights of California Residents. If you reside in California and have provided us with your personal information, you may request information about our disclosures of certain categories of personal information to third parties for their direct marketing purposes.
