## 9. England Squash Affiliation

Paul Makinen presented the new affiliation scheme for individual memberships and clubs.

Geoff Walton Explained:

- The NWCSL Constitution states that clubs must be affiliated members of ES for their teams and players to play in the NWCSL. A change in the constitution can only be made at an EGM or AGM.
- Players must be affiliated to ES to play in ES sanctioned events, inter county and for England.
- Cheshire, Lancashire, and Merseyside receive an enhanced rebate from England Squash based on the number of clubs and players within their respective counties. The affect of clubs and players not becoming members will have a negative impact on funding within the counties and some development projects may not take place
- A reduction in ES Membership would almost certainly have a negative financial impact on funding from Sport England to ES.
- A strong governing body is essential for squash development at all levels.
- The NWCSL committee support the new ES affiliation scheme

The floor was invited to comment on the new ES membership. There was a concern that players would not join the new scheme. How would casual team players be treated? Would they have to join the new scheme if they only play 2 or 3 times in a season. Action ES to come up with a solution for casual team players prior to the 24-25 season start in September. GW to follow up.

10. Women in Squash

Hannah Hodgson Chair for Cheshire asked the NWCSL to support the Women in Squash Project. The objective is to engage more women and girls in squash.

The Pilot project will set individual goals, action, support and reflections within groups of women and girls. There will be monthly online network meetings led by an experienced coach-mentor including guest speakers from the world of sport. Groups will communicate through social media platforms such as Facebook and WhatsApp.

The outcome being a connected community using their voice for positive change across squash.

The ask is for the NWCSL to cover the pilot project cost of £5000 to provide initial data and insight to present to England Squash. Action to be discussed at the next NWCSL committee meeting.

#### League Restructure:
