DAY 1 COVERAGE

Available only on Levels 3 & 4; Included on Level 5. Waives the standard 30 day/1,000 mile Waiting Period. Available for vehicles with up to 150,000 miles at time of purchase.

EMISSIONS COMPONENTS

Available on Levels 1–4; Included on Level 5. Covers the catalytic converter, exhaust pipes; fuel and vapor vent valves, solenoids and sensors; diesel exhaust fluid injection systems, vacuum canister and reservoir, vapor canister; air pump, lines and valves; vapor return lines, valves, solenoids and sensors; gas cap and filler neck.

HIGH TECH
