## **About This Investment**

#### **Investment Description**


The Truvius Equal Sector model is a broad multi-asset portfolio equally allocated to five Truvius sector indices spanning the digital asset economy. This model is designed for diversified exposure in a way that reduces concentration in any one sector. Allocations to the indices rebalance automatically, with each sector index adhering to its own criteria.

#### **Investment Style**

Our Market models represent broad multi-asset systematic exposure to the overall crypto market. Market investments effectively capture broad exposure to the overall digital asset ecosystem and have lower fees vs. our Smart Beta and Alpha investments.

#### Why Invest?

Our Equal Sector model may be suitable for investors seeking a more sector-diversified, less concentrated portfolio spanning a wide range of industries across the crypto economy. This model is less concentrated in mega cap assets like Bitcoin and Ethereum and takes a more equal-weighted approach to investing in crypto markets.






