Stellar Expert is a trusted third-party application which provides the user with aggregated data on the Stellar Network activities.
- The Reserve Accounts Report refers to the accounts held in regulated financial institutions with published monthly attestations. The USDC balance is at least equal to or greater than the Stellar balance at each Report Date and Time. This does not contemplate the impact of outstanding checks/wires, deposits in transit or other reconciling items.
