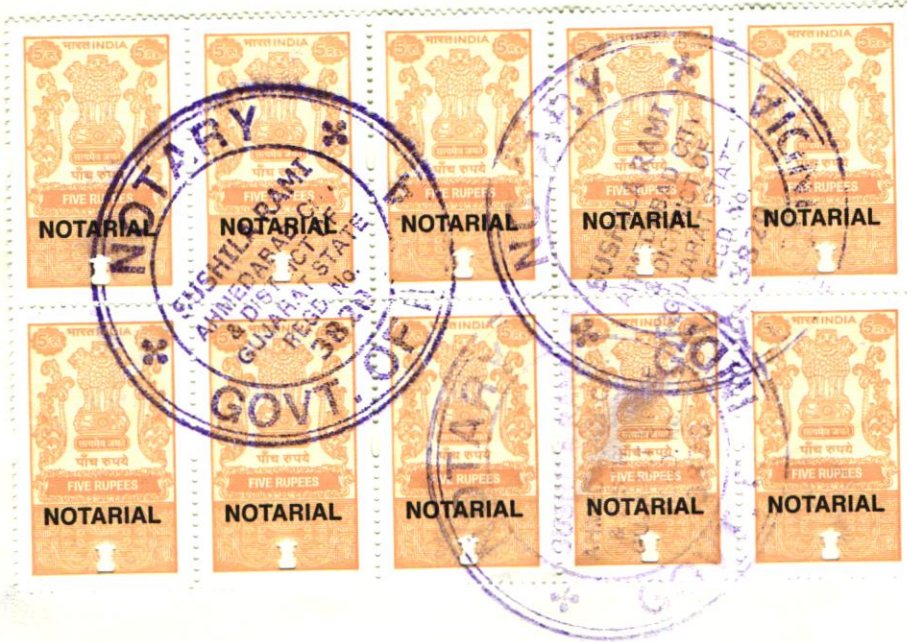

SUMIT CHAMPALAL AGARWAL S/o Shri Champalal Agarwal, Hindu, Adult and residing at: 699 FP 101, Saraswati Darshan Society, Behind Hira Rupa Hall, Ambli Bopal Road, Bopal, Ahmedabad, Gujarat-380058, which expression shall, unless it be repugnant to the subject or context thereof, include their legal heirs, successors, nominees and permitted assignees and hereinafter called the **SECOND PART**; AND

SACHINKUMAR SANTKUMAR AGRAWAL S/o Shri Santkumar Banwarilal Agrawal, Hindu, Adult and residing at: 43, Basant Bahar-I, Near Sterling Club, Bopal, Ahmedabad, Gujarat-380050, which expression shall, unless it be repugnant to the subject or context thereof, include their legal heirs, successors, nominees and permitted assignees and hereinafter called the **THIRD PART**.

WHEREAS this Agreement is supplemental to the initial LLP Agreement dated 23rd June 2021 and first supplemental agreement dated 4th August 2021 made between the parties of the FIRST PART to the parties of the THRID PART whereby they had agreed to form a LLP in the name and style of M/s. ALPINE COTTWEAVE LLP to undertake various ancillary and other businesses to be carried over by LLP as specified in the said LLP agreement.

AND WHEREAS all the parties to this agreement with objective of business expansion has decided to alter Clause 6 of the Initial LLP agreement thereby increasing the Capital Contribution of the LLP from Rs. 10,00,000/- (Ten Lac Only) to Rs. 12,00,00,000 (Twelve Crore Only) which shall be contributed by all the partners in the proportions of their profit sharing ratio or any other proportion as may be mutually agreed upon by all the partners.

NOW, The First, Second and Third Party intend to write down the terms and conditions of the said supplemental changes;

IT IS NOW THEREFORE AGREED AMONGST THE PARTIES HEREIN AS FOLLOWS:

1. **Clause 6** of initial LLP agreement shall be substituted with following clause:

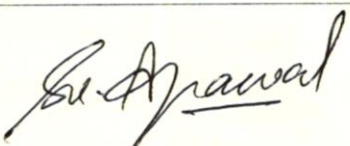
“Clause 6. The fixed capital contribution of the Limited Liability Partnership shall be Rs. 12,00,00,000/- (Rupees Twelve Crore Only) which shall be contributed by all the partners in the following manner:

The further Contribution if any required by the LLP shall be brought in by the partners in their profit sharing ratio, or in any other proportion as may be mutually agreed upon by all the partners.”

Except amendment made by this Agreement, the initial LLP Agreement along with other supplemental agreements made shall hereafter be construed as if the same had been executed by the existing Partners.
