MR. SACHINKUMAR SANTKUMAR AGRAWAL, S/o Santkumar Banwarilal Agrawal, Hindu, having [PAN: AAQPA0559A] and [AADHAR NO: 8116 4193 7108] residing at 43 Basant Bahar-I Near Sterling Club Bopal Ahmedabad Gujarat - 380050, which expression shall unless it to be repugnant to the subject or context thereof, include their legal heirs, successors, nominees, and permitted assignees and hereinafter called the "**THIRD PART**" or "**CONTINUING PARTNER**", and

M/s. ALPINE SPINWEAVE PRIVATE LIMITED, a Company registered under Companies Act, 2013 having its registered office at Khata No 670, Block No 614, Village Paldi, Paldi Kankaj, Ahmedabad, Gujarat - 382425 acting through its Nominee Mr. Sandeepkumar Agrawal residing at 34, Basant Bahar Bunglow-3, Nu. Homeopathy College, Bopal, A/bah which expression shall, unless it be repugnant to the subject or context thereof, include their legal heirs, successors, nominees and permitted assignees and hereinafter called the "**FOURTH PART**" or "**INCOMING PARTNER**".

(Existing Partners and Incoming Partners shall be jointly known as "the parties")

WHEREAS:

- the parties to the FIRST to THIRD Part were carrying on their existing business under the name and style of M/s. ALPINE COTTWEAVE LLP (LLPIN No. AAX-2607) (hereinafter referred as LLP) having its registered office at Khata No. 670, Block No. 614, Village Paldi, Paldikankaj., Ahmedabad, Gujarat - 382425 on the terms of the initial Limited Liability Partnership Agreement dated 23rd June 2021 and supplemental agreements executed thereafter.
- this Agreement is supplemental to the initial Limited Liability Partnership Agreement dated 23rd June 2021, first supplemental agreement dated 04th August 2021 and Second supplementary agreement dated 16th February, 2023 executed between the Existing Partners.
- the Retiring partner of this agreement has shown his unwillingness to continue as a Designated Partner/Partner of the LLP vide his resignation letter dated 25/10/2024 and has requested for consent of all the existing partners to accept his resignation with immediate effect subject to the terms and conditions of mentioned in the initial LLP Agreement and modifications made in supplemental agreements entered thereafter. In view of the same, it is hereby agreed between the existing partners to accept his resignation with effect from 25th day of OCTOBER, 2024 and the Continuing Partners have opted to purchase the contribution of the retiring partner and will continue the LLP with such modification as agreed hereupon.
- the incoming partners of this agreement has shown its willingness to join the LLP as partner and have requested for the consent of all the existing partners to accept their induction in the LLP as a partners and it is hereby agreed by the existing partners that with effect from 25/10/2024, the said incoming Partners shall be deemed as partners subject to the terms and conditions of mentioned in the Principal LLP Agreement and the Supplemental agreement subject to the modifications accepted by this Agreement

WHEREAS the said LLP Agreement requires parties to reduce in writing to Supplement Agreement any changes in the said LLP Agreement under clause 41 of the LLP Act.

1. NUMBER OF DESIGNATED PARTNERS:

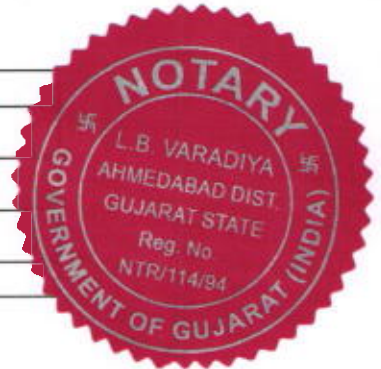
The following person shall act as Designated Partners of LLP in terms of the requirement of the Limited Liability Partnership Act, 2008 namely:
