# **Terms of Service**

#### 1. Introduction

Welcome to Saibon Group AB ("Saibon", "Saibon," "we," "us," "our"). These Terms of Service ("Terms") govern your use of our website (www.saibongroup.com) and services (collectively the "Service").

#### 2. Definitions
