

This agreement is legally binding and forms a contract between the photographer (Johnny Georgiou) and the client (you). Please read carefully, fill out the appropriate sections and then return the form to secure your booking.

- **Step 1**: Read through the contract carefully
- **Step 2**: Fill out the required sections, scan and send back to johnny@johnnyx.au
- **Step 3**: After our initial meeting you will have 2 weeks to pay your deposit to secure your booking. Please note this contract is binding only from the date of deposit payment, I will secure your proposed date and hold that date for this 2 week period. If no deposit is made then the date is forfeited and you will have to contact the photographer (Johnny Georgiou) to secure that date again.
- Step 4: We plan your shoot using the schedule for each type of shoot listed below.
- **Step 5**: This is shoot day
- **Step 6**: Delivery of final images upon receipt of final payment. Please note delivery does not take place until all outstanding fees and payments are paid in full.

Hair Photography

- Half day rate 1 to 3 finished looks
- Full day collection 6 to 8 looks

Packages come in two forms:

- A half day shoot which results in 1 to 3 high end edited images suitable for single or multiple entry industry competitions.
- A full day shoot which results in 6 to 8 high end edited images suitable for a competition that requires a full collection. As most collection categories require 6 finished photos, I have allowed for the extra 2 looks, my experience has shown me that it's always great to have the 1 or 2 extra looks in case one of your planned shots isn't quite right for the whole collection. In brief meetings I will always encourage you to shoot those extra looks as a backup.

Each package is identical with the only difference being the number of finished images and includes the following:

- Initial brief meeting to discuss concept, set design and overall feel of the shoot.
 - o Please bring your mood boards and any other images you feel you need to convey your desired result. At this meeting we will discuss your proposed result and lock down your editing look.
- Pre-shoot meeting 2 weeks before the shoot to finalise details and go through a run sheet for the day. (This must be ready for the meeting in order for your day to run smoothly)
- Shoot day which generally runs for approximately 8 hours allowing some flexibility. (Note anything above a 10-hour day will incur a surcharge of \$100 per hour)
- Post shoot meeting to narrow down best images and select final images to edit.
 - At this point you have the option to adjust any changes to your proposed edit style, keeping in mind these changes are usually colour to black and white and vice versa, any other changes may be discussed however they may not be possible due to how your images were shot from a lighting, direction and style point of view.
- Pre-delivery meeting to review edits and make any final adjustments.
- Final delivery of images on a USB. (Your images will come in several formats: Full resolution uncropped,
 Full resolution cropped to size, Medium or Low resolution cropped to size as dictated by specific
 competition requirements. You will also receive the narrowed down images from pre-selection in Low res
 format for future reference should you require further edited images)

What's not included:

- Any editing that is a change from your original brief. Should you change your mind about the direction of the edits after the post shoot meeting there will be a surcharge of \$100 per image already edited that needs to change. It is vital that in the post shoot meeting you are firm with the direction of the edit prior to the commencement of any work taking place.
- Studio space, should you require a studio for the shoot one will be made available at an extra charge of \$600 for the day.
- Travel costs outside of Adelaide metropolitan area, eg rural, country or interstate. All travel cost will be additional, this includes flights and accommodation as well as luggage costs for equipment.



Wedding shoot

Breakfast to bed

Your wedding is your big day to shine, and I will be there with you from the moment you wake up until you leave your reception to capture every moment. My style is more phot journalistic to be able to cover the candid moments as well as create classic wedding portraiture in your after-ceremony shots.

Your package will include the following:

- Initial meeting to discuss your day and review the checklist of required photos.
- Pre-wedding meeting (usually a month before hand) to review final required shot checklist and visit wedding location to plan out the required shots and discuss any specifics regarding the venue, times and family or quests involved.
- Bride and groom getting ready.
- Ceremony
- After photos of bride, groom, and wedding party, as well as family.
- Reception
- All images in low res format unedited (These will be a narrowed down set of images, usually approx. 500 shots)
- 150 fully edited shots for socials sharing etc.
- 10 high end edits of your choice suitable for printing in large format
- 1 round of minor edit changes (these include any tiny details that you are not happy with and overall colour grade of the set of images)
- A high gloss hard cover coffee table album of all edited shots
- A link to purchase more albums at wholesale price for 3 months after delivery of your final images.
- Metropolitan travel is included, any interstate or rural/country travel and accommodation is an additional cost covered by the bride and groom.

Note: Drone photography is included should the client wish.

Custom shoot

If you have a brief or idea for a custom shoot, then we can get together to discuss your goals in a no obligation meeting. Custom shoots can be anything from physique shoots, modelling portfolios, pre-wedding images, or simply a shot that can be used for your socials. These can be in studio or on location and are priced starting from \$250 onwards depending on your needs and location requirements.

Terms and conditions:

- 1. This is a legally binding document between the photographer (Johnny Georgiou) and the client (you).
- 2. You are entering this agreement of your own free will and agree to abide by all the terms and conditions.
- 3. The photographer (Johnny Georgiou) owns ALL RIGHTS to the photos produced on the day.
- 4. As the client, you are purchasing a lifetime license to use the photos produced on the day.
- 5. The photographer (Johnny Georgiou) reserves the right to use the photos produced on the day across their social media platformsstrictly for the purpose of promoting their services.
- 6. The client (you) shall not digitally alter any photos produced on the day and share across any digital or social media channels they or any of the agents/associates own.
- 7. The client (you) shall not resell or onsell the photos produced on the day for financial or any other gain without the express permission of the photographer (Johnny Georgiou).
- 8. No photos produced on the day are to be used any pay per view digital channels by the client (you).
- 9. Upon delivery of finished works the photographer discharges all responsibility for further duties and works.
- 10. Refunds will only be given in extreme circumstances and these are at the discretion of the photographer (Johnny Georgiou). It is assumed that delivery, which occurs after final round of adjustments ends the contractual obligations of said photographer.
- 11. In any case where the client (you) is still dissatisfied with the results produced on the day they must contact the photographer (Johnny Georgiou) within 7 days in writing to seek resolution. No correspondence shall be entered into after this 7 day pariod.
- 12. SOCIAL MEDIA: Any deffamatory texts either written or visual that is produced for the social and digitalmedia of the client (you) and their agents/associates against the photographer (Johnny Georgiou) or their agents and associates will result in criminal prosecution.
