>>> PATIENT FOCUS - SETTING THE STANDARD FOR PATIENT PRIVACY AND CONFIDENCE

A survey of 65 patients revealed that approximately one-fourth expressed privacy concerns when using telemedicine services.¹

Although telehealth visits with a clinical provider provide the same level of privacy as face-to-face meetings, telehealth technologies can create privacy concerns with some patients regarding the security of health information and discussions.

Driven to address this critical issue, the Vitalchat team, under the leadership of Ghafran Abbas, Co-founder and Chief Technology Officer, developed a groundbreaking lens, featuring Smart Glass. This innovation allows the glass to appear transparent when used and opaque when inactive. As such, it provides additional reassurance when the camera is deactivated.

Set for launch this summer, this innovation (patent pending), allows for two distinct indicators for 100% privacy assurance during virtual nursing visits. Abbas explains, "The optical, high-quality mobile camera instinctively repositions when not in use while the fixed camera, similar to your phone, becomes opaque to identify when not in use. These visual indicators are important for patients to feel their privacy is always top of mind."

Vitalchat's goal is to make patients, nurses, and the extended team as comfortable and confident as possible, throughout every interaction. This objective applies to privacy and security, as well. This difference is another example of Vitalchat's commitment to "nursing simply" – straightforward integrations with significant benefits.

>>> CMS UPDATE: STATE MEDICAID AND CHIP TELEHEALTH TOOLKIT

CMS recently released an updated "State Medicaid and CHIP Telehealth Toolkit". It identifies specific policies to be addressed by states to allow wider adoption of telehealth services. In doing so, Americans will more easily access, electronically and virtually, important healthcare services.

The updated toolkit addresses benefit flexibility, financing, workforce, managed care, and quality reporting. In addition, it outlines strategies for delivering specific services via telehealth to different populations.


An additional focus on telehealth strategies is an important step toward improving health equity, providing services to specific populations, including children and youth, and delivering maternal and behavioral health services.

Among the telehealth service modalities covered are:

- Two-way, real-time audio/video, and multi-person video calls
- · Audio calls only
- · Asynchronous communications contact between two parties that does not require real-time interaction
- Remote Patient Monitoring

SIMPLE THOUGHTS

>>> DON'T TAKE IT FOR GRANTED -TIPS FOR GETTING THAT GRANT

We think a lot about what a "day in the life" is for the nurses, doctors, caregivers, administrators, and patients we serve. That means trying to help with those things that may not seem directly related to virtual nursing but may be critical for your team.

We know you and your team are completely committed to evolving your telehealth infrastructure for improved patient care. Now comes the not-so-fun part – acquiring funding.

First, it's critical that you and your colleagues plan appropriately. Witting a winning grant takes preparation. Think of it as taping off your room before painting – it may take more time than you prefer, but it significantly impacts the result.

That means a well-thought-out plan to get funding that will make it clear why your grant application deserves funding more than the other options. And, remember - grants aren't that different then caring for patients.

The numbers matter. That means data. Whether it's statistics, population data, or quantifiable outcomes data specific to your request, numbers speak volumes.

Now that you have a plan in place supported by data, here are a few tips for framing a healthcare grant proposal that gets noticed...and awarded!

- Whether for research or to provide better patient care, make sure you are clear on what compelling and impactful results you are expecting to obtain.
- Ensure that a clear outcomes basis (scientific, efficiency, etc.) is established.
- Make it clear how the proposed work will be leveraged the more scalable the better.
- As the saying goes no need to "boil the ocean". More focus means more based in reality and that's a good thing. As long as we are quoting, remember what Leonardo da Vinci said: "Simplicity is the ultimate sophistication".
- Innovation is key. Perhaps you are seeking a grant that falls into a common category but that doesn't mean how you plan on integrating, scaling, etc. is the same as everyone else. Make sure to be clear about why your plan is a winning one.
- That being said...don't skimp on the details. Make sure that any reviewer questions can be answered as much as possible in your proposed plan.
- Highlight your team's expertise to succeed at what you wish to accomplish (and for the inputs provided to the grant).
- · Confirm the proposed time and effort of study team members are sufficient.
- Patients! Don't forget to explain why this is better for your patients (and you're your staff).
- Supporting literature don't forget to cite where it makes sense.
