1. INTRODUCTION

This Cookie Policy explains how Blytz Cashless ("we", "us", or "our") uses cookies and similar technologies on our domain, subdomains, their hosted websites (www.blytzcashless.com) and our mobile application. This policy is designed to help you understand what cookies are, how we use them, and the choices you have regarding their use.

2. WHAT ARE COOKIES?

Cookies are small text files that are placed on your computer or mobile device when you visit a website or use a mobile application. They are widely used to make websites and apps work more efficiently and to provide information to the owners of the site or app.

3. HOW WE USE COOKIES

We use cookies for a variety of reasons, including to:

4. TYPES OF COOKIES WE USE

4.1 Strictly Necessary Cookies

These cookies are essential for you to browse our website and use its features, such as accessing secure areas of the site. Without these cookies, services you have asked for cannot be provided.

4.2 Performance Cookies

These cookies collect information about how you use our website and mobile app, for instance, which pages you go to most often. These cookies don't collect information that identifies you. All information these cookies collect is aggregated and therefore anonymous. We use these cookies to:

- Analyze how our website and app are used
- Improve our services

4.3 Functionality Cookies

These cookies allow our website and mobile app to remember choices you make (such as your username, language, or the region you are in) and provide enhanced, more personal features. They may also be used to provide services you have asked for. The information these cookies collect may be anonymized and they cannot track your browsing activity on other websites.

4.4 Targeting Cookies

These cookies are used to deliver adverts more relevant to you and your interests. They are also used to limit the number of times you see an advertisement as well as help measure the effectiveness of advertising campaigns. They are usually placed by advertising networks with our permission. They remember that you have visited a website and this information is shared with other organizations such as advertisers.

5. MOBILE APPLICATION COOKIES AND SIMILAR TECHNOLOGIES

Our mobile application may use cookies or similar technologies like device identifiers, SDKs (Software Development Kits), or local storage to remember your preferences and optimize your user experience.

6. THIRD-PARTY COOKIES

We may allow third-party service providers to place cookies on our website and mobile application to perform various functions. These third parties may include:

- Analytics providers (e.g., Google Analytics)
- Advertising networks
- Social media platforms
- Payment processors

Please note that we do not have control over these third-party cookies. You should check the third-party websites for more information about these cookies and how to manage them.

7. MANAGING COOKIES

Most web browsers allow you to manage cookies through their settings preferences. However, if you limit the ability of websites to set cookies, you may impair your overall user experience, as it will no longer be personalized to you.

To manage cookies on our website, you can:

For our mobile application, you can manage similar technologies by:

- Resetting your device's advertising identifier
- Opting out of targeted advertising in your device settings
