



1. SPIRO WARRANTY COVERAGE

1.1 Spiro warrants that the motorcycle model Ekon450M1 & Ekon450M2 (hereinafter referred to as the "Product(s)") will be free from defects in materials and workmanship defects. The parts warranty coverage is as per the Annexure 1 mentioned below from the date of delivery of the product.

1.2 This warranty is valid only for the original Buyer and is not transferable unless otherwise agreed upon in writing by the Spiro.

2. SCOPE OF WARRANTY

2.1 Spiro agrees to repair or replace the defective Part, at our discretion, if a defect arises and a valid claim is received within the Warranty Period.

2.2 This warranty does not cover any damage or defect caused by:

- Misuse, neglect, or improper handling;
- Unauthorized repairs, modifications, or alterations to Wiring harness or other components;
- Use of the Product for purposes other than those for which it is designed;
- Normal wear and tear;
- Accidents or natural disasters, including but not limited to fire, floods, or earthquakes.
- Situations that have no substantial negative impacts on overall performance or normal use of Product, such as noise, vibration, oil leakage, faded exterior colors, and rust on metal parts.
- Defects, malfunctions, anomalies, damages and/or other adversities caused by air pollution, bird droppings, oxidization, weathering, sulphur, salts, chemical agents and/or similar substances.
- Defects, malfunctions, anomalies, damages and/or other adversities caused by acrobatic performance, racing or riding on surfaces other than usual paved roads.
- Defects, malfunctions, anomalies or damages caused by the failure to perform or receive regular maintenance services by Partner or by Partner's customers; Defects, malfunctions, anomalies or damages caused by the inappropriate use, maintenance or repair on the Spiro Vehicles, such as the maintenance or repair not carried out with Spiro's Special Tools or lubricating Oils or that was performed by a third party not authorized or recognized by Spiro.

3. CLAIM PROCEDURE

3.1 To make a claim under this warranty, the Buyer must notify Spiro within 15 Days of discovering the defect.

3.2 The Buyer must provide proof of purchase and any other information reasonably requested by the Spiro.
