PURPOSE

Coolbinia Primary School provides every student with the educational support the student needs to learn and maintain positive behaviour. This policy has been developed to positively managing student behaviour by using educational processes to teach students responsibility.

SCOPE

This policy applies to all students and staff at Coolbinia Primary School.

DEFINITIONS

Term	Definition			
Behaviour	A student's learned actions, identified in a school's code of conduct, that contribute to the student's growth and development and the school's good order and proper management.			
Behaviour Support	The educational support a student receives from the school in order to learn and maintain identified behaviour.			
Student	A person who is enrolled at Coolbinia Primary School			
Good Standing	l students commence with, and retain, Good Standing while exhibiting chaviours that align with the school's values and beliefs.			

Definitions specific to this policy include:

1. PRINCIPLES

- 1.1. To create a positive learning environment within the school and classroom so that teachers and students can work and learn together without distraction.
- 1.2. To recognise members of the school community whose behaviour promotes a positive and caring school environment and to involve students in a positive way by encouraging and recognising their contributions.
- 1.3. To encourage students to accept and follow appropriate boundaries.
- 1.4. To establish a clear set of consequences for students who do not accept their responsibilities, so they are encouraged to understand and respect the rights of others.
- 1.5. To establish procedures so that conflicts can be resolved in a positive and appropriate way.
- 1.6. To enhance students' self-esteem and self-worth together with pride in themselves, school, home, and community.

2. ROLES AND RESPONSIBILITIES

- 2.1. The Principal is responsible for ensuring that the Policy is understood and accepted by the teachers, students, and parents at Coolbinia Primary School.
- 2.2. The Principal and staff must provide individual student Behaviour Support where the need is identified.

3. PROCESSES AND PROCEDURES

- 3.1. Behaviour issues can be raised verbally, or in writing with a member of staff in the first instance and the Principal following this.
- 3.2. Loss of Good Standing occurs after a suspension or series of behaviours that are not aligned with the school student behaviour plan. These behaviours must include, but are not limited to:
 - 3.2.1. Starting a fight
 - 3.2.2. Making physical contact with the intention to harm another student or staff member.
 - 3.2.3. Videoing a fight in the grounds of the school or off site where there is reasonable nexus between the incident and the school, with the intention of publishing on social media.
- 3.3. Re-instate good standing:
 - 3.3.1. Implement a restorative and educative return to school process to re establish positive behaviour.
 - 3.3.2. Develop a re entry and/or individual behaviour plan focusing on the identified areas for improvement citing strategies, milestones and desired outcomes.
 - 3.3.3. Re instate a student's Good Standing after such period as decided by the Principal.
