PROGRAM OVERVIEW

- **Target Audience:**

Executives and business leaders seeking to attain a higher level of specialization in management beyond what is typically provided in general management programs.

Following a comprehensive assessment of individuals' research interests, each participant will be matched with an academic advisor. The advisor's responsibility is to provide assistance and guidance to the candidate, ensuring successful completion of the program.



PROGRAM OBJECTIVES

Upon completion of the program, candidates can expect to acquire the following array of skills:

- 1.** Analyze and understand complex phenomena associated with current business practices.
- 2.** Enhance their business research skills.
- 3.** Interpret the phenomena of interest in the context of a broad range of academic literature.
- 4.** Identify gaps in management literature that can lead to the generation of new knowledge.
- 5.** Formulate research questions that are relevant to specific audiences.
- 6.** Develop a research design to collect data relevant to the phenomenon studied.
- 7.** Analyze data and employ rigorous statistical analysis to interpret the data and evaluate its alignment with the proposed theory.
- 8.** Generate original knowledge that is both theoretically sound and practically applicable.
- 9.** Understand the ethical implications of conducting research in social settings.
- 10.** Learn how to effectively communicate theory and findings to a specific audience.

PROGRAM PHASES

ESLSCA DBA STRUCTURE

PHASE ONE

BUSINESS FUNCTIONS

Consists of the foundational courses in the major functional areas of business.

PHASE TWO

BUSINESS ANALYSIS TECHNIQUES

Courses in this phase allow students to develop solid analytical abilities. Independent Studies courses are intended for students to strengthen their specialization knowledge in the selected area(s) of interest.

PHASE THREE

DISSERTATION

Students are required to conduct original research on a topic of current significance and personal interest. Each student is expected to design a study that addresses complex practical challenges. Upon completion of their research, students must analyze and present the data, write a dissertation, and defend it in an oral examination.

- The program includes three phases with a total of 60 Credit hours.
- Students may complete the entire program in a minimum of 3 years, with the possibility of extending it to a maximum of 6 years if necessary.
- Students are highly recommended to start the program with a proposed research topic in mind and develop it over the course of three years.

● **ADMISSION & REGISTRATION**

- Two recent personal photos.
- A copy of the ID or passport.
- If the candidate is not an ESLSCA University MBA graduate, he/she must provide an official test score (TOEFL score 500 or IELTS score 5).
- Official transcripts, forwarded directly by previously attended colleges and universities (MBA, MSc, or MA in Business Administration).
- Original transcripts for all university courses. Applicants must have a cumulative GPA of at least 3.0 at the end of their MBA to join the DBA program.
- Professional resume.
- Statement of purpose (approximately 1000 words addressing the candidate's goals and reasons for seeking a doctoral degree).
- Two letters of recommendation reaffirming the candidate's ability to pursue a doctoral program.
