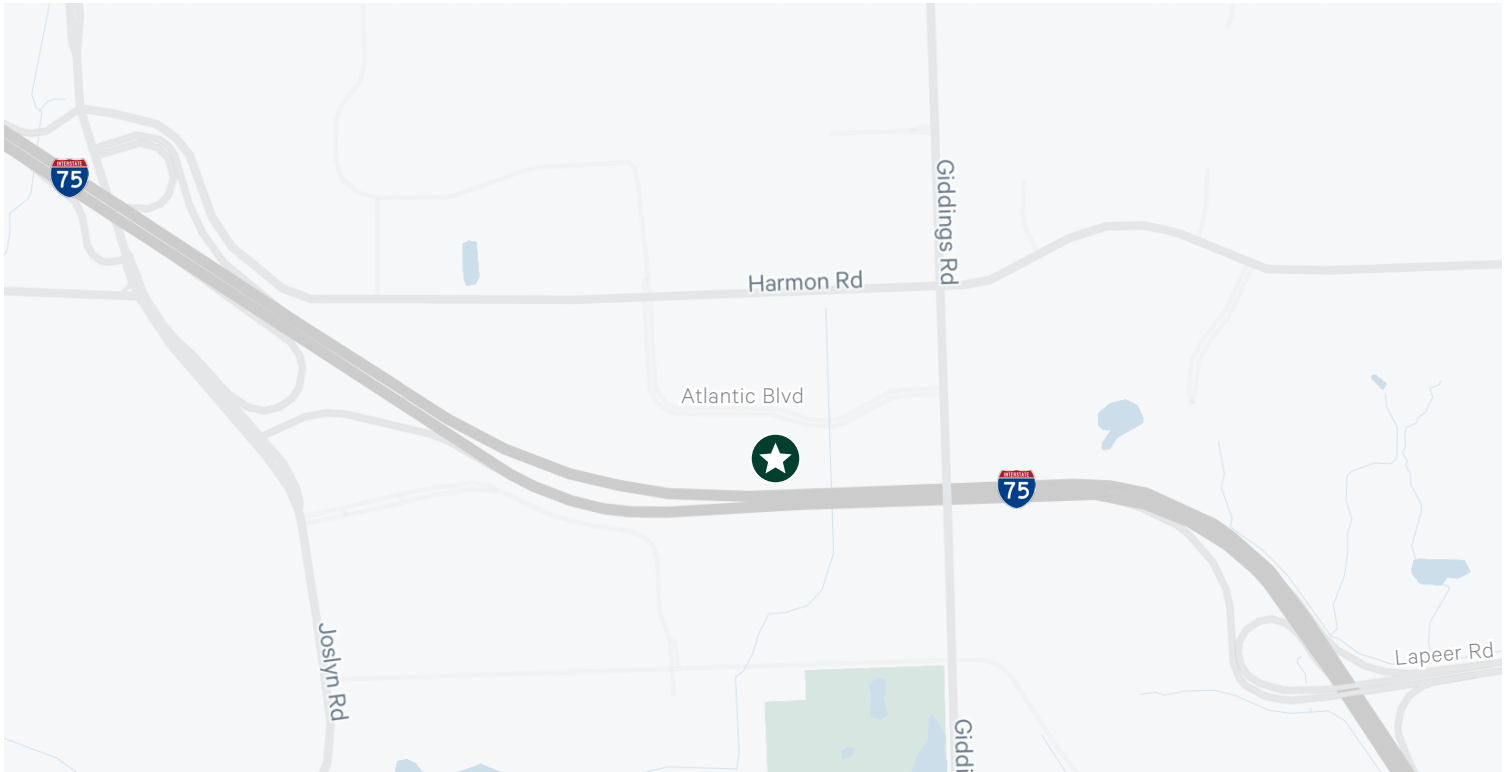

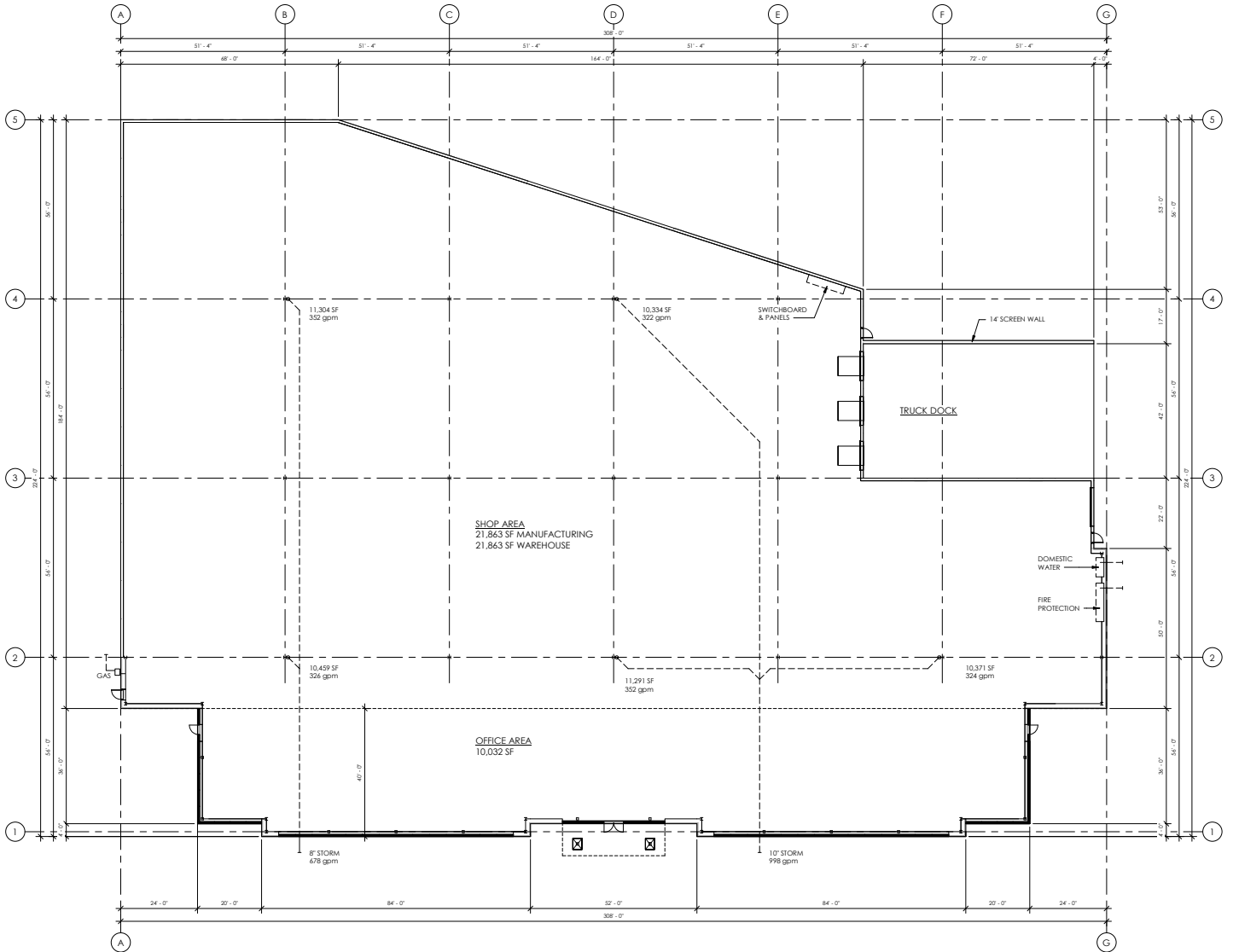

Foor Plan



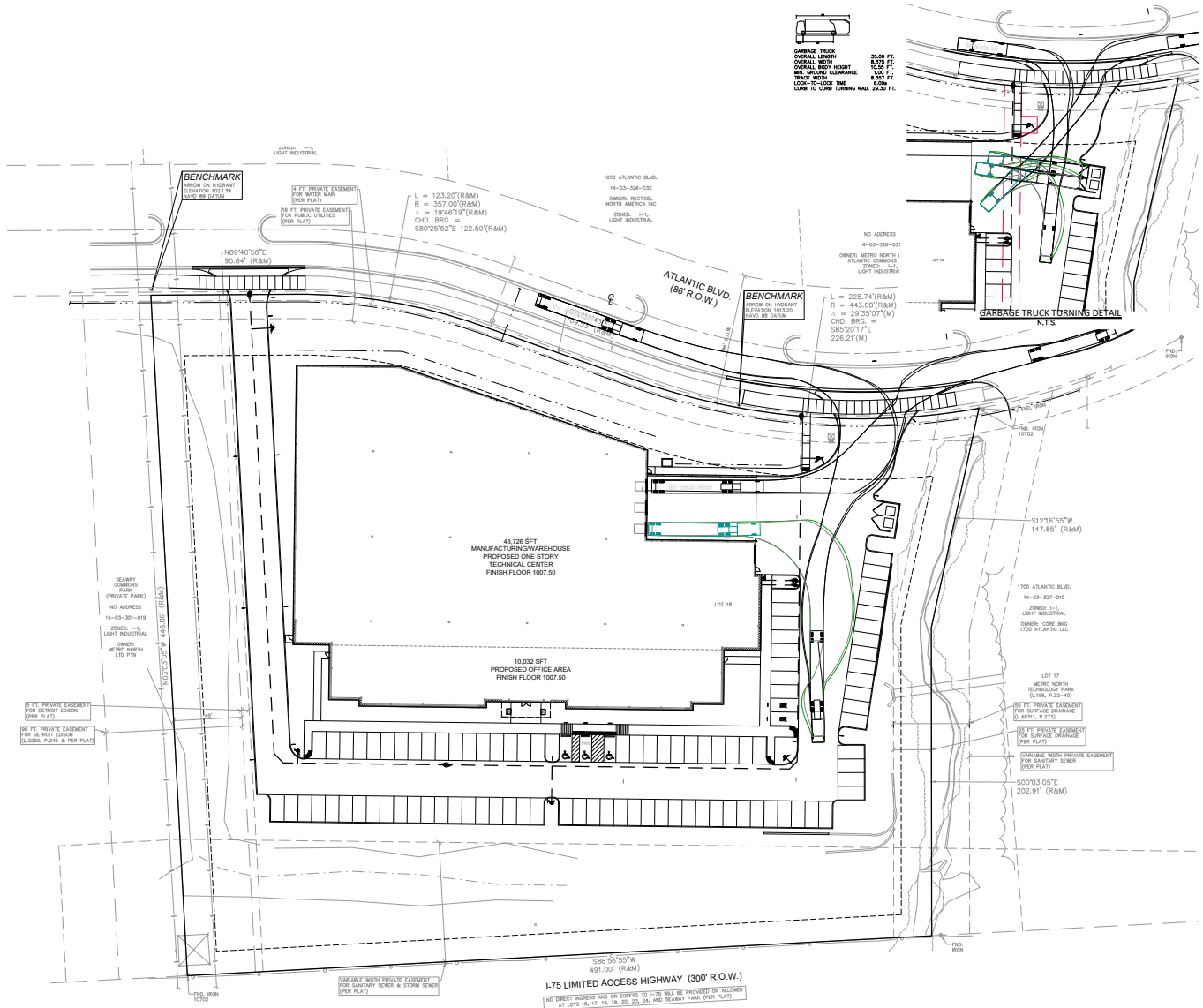
