

FACTORY INSPECTIONS

We conduct regular factory inspections. In our last round of inspections, this is what we discovered.

1. Sophisticated, efficient and automated processes

Consistency and reliability is very important to us at UKSOL. The utilisation of reliable, automated and well documented processes and procedures ensures that we deliver a great quality product every time.

2. Highly educated and predominantly local workforce

Not only was the workforce highly educated and predominantly local to the factory, but also earning far more than the industry average for manufacturing.

3. No indication of forced labour

Explicitly no indication of any forced labour during our visits and no roles conducive to low skilled work which carry higher labour rights risk.


