| Seed Treatment | Maize group and soybeans: 200 g MITY-GROTM p/50 kg seed. Oilseed crops: 300 g MITY-GROTM p/25 kg seed. Lucerne: 200 g MITY-GROTM p/12.5 kg seed. | Apply directly to seed. Suspend product in as much water as is necessary to form slurry. Mix the slurry with seed until all seeds are evenly coated. Let dry and plant seed as soon as seed is manageable. |
| In-furrow Application | 800 g MITY-GRO p/ha in-furrow | Apply as a suspension on the seed in the planter furrow. Use as much water as is convenient. Ensure thorough agitation in the application tank. |
| Soil and Irrigation Application (drip or pivot irrigation) | 400 - 800 g MITY- GROTM p/ha | Mix thoroughly before applying through irrigation system. Use as much water as is necessary. |
