Research: In November 2019, CES conducted a nationwide poll of the early  
Democratic primary race to examine how polling results look under  
various alternative voting methods. This poll provided an educational  
opportunity for the public to better understand how alternative  
voting methods work and how those methods can improve elections.

Public Outreach: In 2019, CES expanded it's public outreach on voting methods.  
Significant investments were made in digital marketing to inform the public  
about "approval voting" and other methods using Facebook, Twitter, Google Search,  
and CES email lists. Providing voting method information educates the public  
and brings awareness to new supporters to implement effective voting  
methods. In 2019, CES attended and/or exhibited at 12 international and national  
conferences as well as providing presentations to dozens of stakeholders.  
In addition, dozens of educational articles and blog posts were published on  
the CES website and other media platforms.

Voting Method Advancement: In 2019, CES provided multiple grants to STL  
Approves, a local organization in St. Louis, to launch a signature-gathering  
campaign to get "approval voting" on the city ballot. St. Louis citizens were  
demanding a better method than "vote-splitting" that had been used for decades.  
It is anticipated that STL Approves will have "approval voting" on the  
ballot in 2020 that could make St. Louis the second city in the U.S.  
with "approval voting." A new Director of Campaigns & Advocacy was hired to  
launch "approval voting" chapter programs in local communities to  
set the stage for future national educational campaigns.
