Section 5. Firefighting measures

Extinguishing media

Methods and material for containment and cleaning up

Large spill : Stop leak if without risk. Move containers from spill area. Approach the release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Section 7. Handling and storage

Precautions for safe handling

Avoid release to the environment. Keep in the original container or an approved alternative made from a compatible material, kept tightly closed when not in use.
