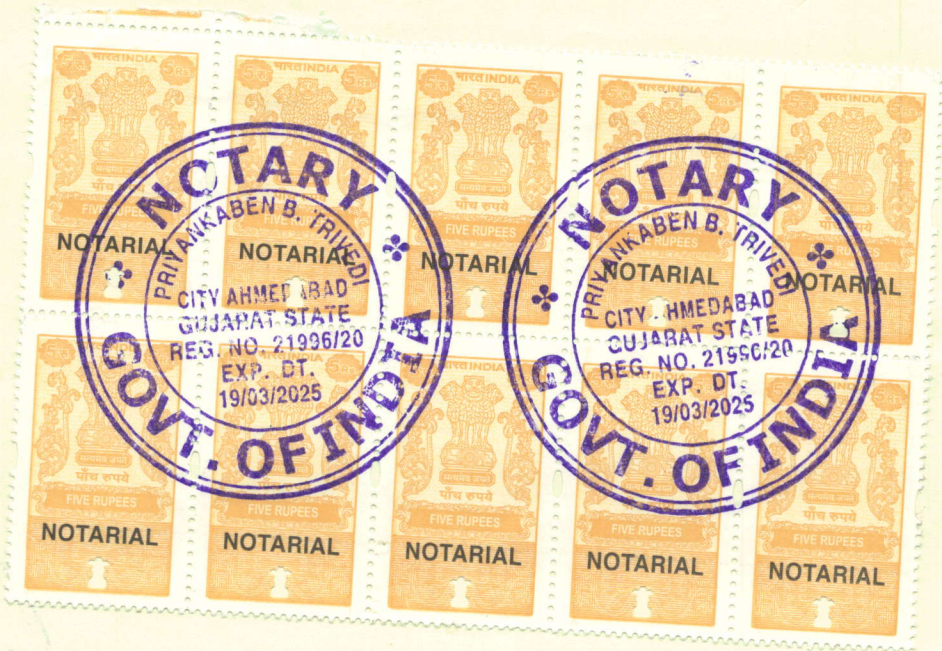

SACHINKUMAR SANTKUMAR AGRAWAL S/o Shri Santkumar Banwarilal Agrawal, Hindu, Adult and residing at: 43, Basant Bahar-I, Near Sterling Club, Bopal, Ahmedabad, Gujarat-380050, which expression shall, unless it be repugnant to the subject or context thereof, include their legal heirs, successors, nominees and permitted assignees and hereinafter called the **THIRD PART**

WHEREAS a Limited Liability Partnership was originally formed under the name and style of "M/s. ALPINE COTWEAVE LLP" (hereinafter referred as LLP) having LLP Identity Number: AAX-2607 and for which a Limited Liability Partnership Agreement was entered between the parties of the FIRST PART to the parties of the THIRD PART on 25th June, 2021 and the same was duly registered with the Ministry of Corporate Affairs (hereinafter referred as "the Principal LLP Agreement").

AND WHEREAS the parties hereto have agreed to carry on business of textiles as mentioned in the Principal LLP Agreement or any such other business as the partners may from time to time unanimously agree upon in the name and style of "M/s. ALPINE COTWEAVE LLP" on the terms set forth in the Principal LLP Agreement.

AND WHEREAS it was unanimously agreed between all the partners of LLP vide passing the resolution dated 25th June, 2021 to change the existing name of LLP from ALPINE COTWEAVE LLP to **ALPINE COTTWEAVE LLP**. Accordingly, the Registrar of LLP, Gujarat has issued a fresh certificate of incorporation consequent upon change of name of LLP on 14th July, 2021.

AND WHEREAS the parties hereto has agreed to make the aforesaid modification in the Principal LLP Agreement subject in all respects to the conditions, stipulations, and provisions of the Principal LLP Agreement, so far as applicable, and except as varied by this deed of agreement.

IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

1. This Agreement is supplemental to the Principal LLP Agreement dated 23rd June, 2021 made and executed between the Existing Partners.
2. **NAME:**

Clause 2 of initial LLP agreement shall be substituted with following clause:

Limited Liability Partnership shall be carried on its business in the name and style of M/s. **ALPINE COTTWEAVE LLP** (hereinafter called as LLP) and the same be changed from time to time by the written consent of all the partners.

Except amendment made by this Agreement, the initial LLP Agreement made at the time of incorporation shall hereafter be construed as if the same had been executed by the existing Partners.

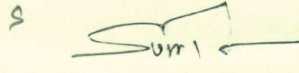
